Training Calendar Discussion/Updates	<p>Motivational Interviewing:</p> <ul style="list-style-type: none"> • Advanced MI training in December training went well, offering MI Basic 2 – ½-day remote trainings in February, ½-day refreshers offered March 24th and Oct. 6th 2021. <p>Law & Ethics: On-line Study Prep-</p> <ul style="list-style-type: none"> • 6 hour self-paced training for up to 16 people and includes full-length practice exam for participants preparing to take the Law and Ethics exam. • Initial Registration will be through Placer Learns, and required secondary registration through Ben Caldwell Labs. • Registration will go live first week of January in Placer Learns. Holiday will send participant registration information to Ben Caldwell labs and they will provide the secondary registration link and instructions to participants via email. • The default training offered is 6-hr self-paced with no CEUs; if users need the 12-hr course with CUEs (previously failed exam), they will enroll in that training that must be completed in order. • If participant enrolls in 6-hr training and does not pass exam, they can enroll in the 12-hour course at not additional charge.

Training updates continued	<p>Implicit Bias:</p> <ul style="list-style-type: none">○ Save the date flyers posted today on Placer Learns for Implicit Bias 101 Awareness training on March 10th (this is the same training held in June 2020) & 201 Mitigation training on March 11th. Each training is 3 hours from 9:00-12:00 held remotely and can accommodate up to 1000 participants. CEU's will be available for both trainings, (participants who took awareness in June 2020 will have to check with their licensing board to see if they will accept CEU's for same training). Registration will in Placer learns will start early January. <p>Cultural Broker Dialogue Series:</p> <ul style="list-style-type: none">• Series of 8, 1.5 hour sessions totaling 12 hours of training for the complete series with up to 40 participants per group.• Training will held on the 2nd and 4th Wednesdays of the month beginning March 24th through July 14th• CEUs will be offered to attendees attending at least 6 of 8 sessions. All sessions are recommended for credit. Number of CEUs to be determined (based on instruction time).• Carlos Rivera will do primary instruction. <p>Indigenous Psychology:</p> <ul style="list-style-type: none">• Usually held in June, Gina Geisler to reach out to trainer to set up training dates and provide follow up. <p>Poverty Simulation:</p> <ul style="list-style-type: none">• Training on hold for FY 20-21 due to COVID restrictions. Currently there is no online version of this training, Gina Geisler suggested looking at SPENT. This is an online game that highlights some realities of poverty. While not as impactful as an in-person simulation experience, it does serve its purpose during this time of social distancing.

<p>Training updates continued</p>	<p>Clinical Supervision (Spring 2021)</p> <ul style="list-style-type: none"> • Remote trainings scheduled with Ben Caldwell- There is a 6-hour webinar for renewing and new supervisors and the nine-hour supplement is intended for new supervisors that are required to complete 15 hours of Clinical Supervision • Participants will have 120 days from their registration date to complete the six-hour Clinical Supervision webinar. • The nine-hour supplement for new Supervisors is a three day, 3 hour per day training that is scheduled March 30th thru April 1st Registration will begin the beginning of February through Placer Learns with secondary registration through Simple Practice, similar to Law & Ethics Study Prep. <p>Trauma Informed Care:</p> <ul style="list-style-type: none"> • Gina and her team are working on post-test to offer CEUs for the Training recorded in September. <p>Substance Abuse Training:</p> <ul style="list-style-type: none"> • WET doesn't usually provide this training, Committee bringing back to the agenda for discussion.
