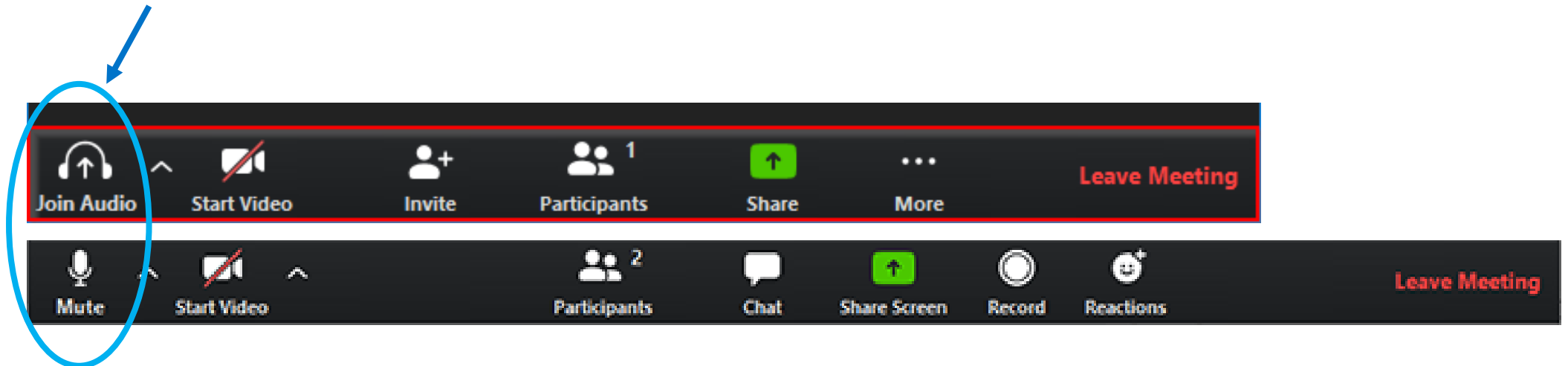

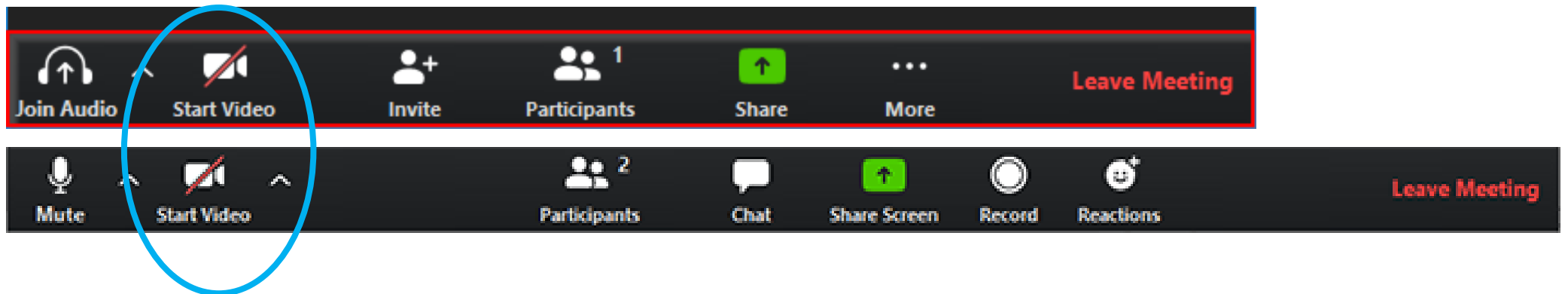

- One of five MHS-A-Funded Statewide Prevention and Early Intervention projects
- Strategic Plan to Reduce Mental Health Disparities written by [California Pan-Ethnic Health Network \(CPEHN\)](#) (Education, Outreach and Awareness consultant)
- Population Specific Needs Assessment and Recommendations Reports: AA, API, Latinos, LGBTQ, Native Americans
- CPEHN formed the [Community-Defined Evidence Practices \(CDEPs\) Integration Advisory Group](#) – released [concept paper](#) in April 2021; Group includes representatives from 17 organizations including the CA Assoc. of Local Behavioral Health Boards & Committees
- 35 Implementation Pilot Projects (IPPs) to apply Community Defined Evidence Based Practices (CDEPs) – different technical advisor assigned to each population
- CRDP Cultural Broker: [Racial Ethnic Mental Health Disparities Coalition \(REMHDCO\)](#) (led the California MHS-A Multicultural Coalition (CMMC) 2011-2016)
