<p>New training ideas continued,</p>	<p>Placer READI Recommendations</p> <ul style="list-style-type: none"> - Sue provided an update; she met with members of PCOE and Resilient Placer we are continuing to make a lot of great connections with other agencies doing this kind of work and continue to bridge these connections and stay informed of training opportunities for WET. 		
<p>Funding Requests</p>	<p>Suicide Prevention :</p> <ul style="list-style-type: none"> • Funding for an additional 40 spots was already approved using the email approval process from the initial 40 approved for priority registration for licensees needing to renew before June 30th • There is demand for this training; currently with the additional 40 registrations already approved, we have with our enrollment, people on the waitlist and email requests the number of participants is at 81 indicating there is a high demand for this training.
